Thank you for your enquiry regarding international cell phone rental. This service is provided by Vodafone Specialist Communications Limited and gives you coverage in over 170 countries*.

PLEASE READ THE FOLLOWING CAREFULLY BEFORE PLACING YOUR ORDER.

Rental will be charged at \$2.99 per day. Calls made and received on GSM cell phones are charged between \$1.99 and \$6.99 per minute and incoming calls in the UK are free of charge. There are no additional surcharges or taxes if you take delivery of the phone in the United States as phones are dispatched from a distribution center in Philadelphia. The delivery costs are shown on the rental agreement and include collection unless otherwise stated.

Voicemail is provided as standard. Incoming calls to voicemail and voicemail deposits are not chargeable. Voicemail retrieval is charged at the applicable per-minute call rate, for the country you are in at the time of the call.

If you have opted for the YouToMe service, you will be supplied with a U.S. based toll free contact number for you international cell phone. You can distribute this number to your contacts in the U.S. who can then call you free of charge. There are no international dialing or long distance charges. You can also forward your US based cell phone to the YouToMe toll free number. Your U.S. cell phone provider will charge you for the leg of the call from your U.S. cell phone to the YouToMe number. We will charge you for the incoming call to your international cell phone. Incoming calls in the UK are free of charge.

Payment is to be made by credit card. A valid credit card issued in the name and address that appears on the Agreement is required for Service. We will charge a \$150 deposit on your credit card up to 9 days before the start of your rental to be applied toward the cost of unreturned equipment. While traveling, once you have incurred at least \$150 of airtime charges, the amount incurred will be charged to your credit card. At the disconnection date we will refund your deposit (except where used to off-set equipment costs), by crediting that amount to your outstanding invoice for hire and airtime charges (this process will be repeated if necessary).
